



Figure 1. Count and Rate of Incident Injuries\*, Corry Station NTTC & Navy, AUG 2014-JAN 2016





**Figure 2. Rate of Incident Eye and Hearing Injuries\*, Corry Station NTTC, AUG 2014-JAN 2016**




**Figure 3. Rate of Incident Upper and Lower Extremity Injuries\*, Corry Station NTTC, AUG 2014-JAN 2016**





- Corry Station NTTC & Navy, December 2015**


