



Figure 1. Count and Rate of Incident Injuries\*, NSA Hampton Roads & Navy, AUG 2014-JAN 2016





**Figure 2. Rate of Incident Eye and Hearing Injuries\*, NSA Hampton Roads, AUG 2014-JAN 2016**




**Figure 3. Rate of Incident Upper and Lower Extremity Injuries\*, NSA Hampton Roads, AUG 2014-JAN 2016**





**Figure 6. Percentage of Injured Service Members by Number of Medical Encounters - NSA Hampton Roads & Navy, December 2015**


